FURTHER DETAILS:

- 1) Interested Steel Manufacturing Companies shall submit their applications for empanelment with APSHCL in the enclosed Proforma for supply of various diameters of Fe 415 & Fe 500 grade Steel in straight bars of 12 Meters length to the District units of APSHCL as and when required by APSHCL.
- 2) The interested Steel Manufacturers have to remit an amount of Rs.10,000/- (Rupees Ten thousand only) by way of DD in favour of MD, APSHCL payable at Vijayawada (The deposit amount is non-refundable)
- 3) The rate shall be quoted inclusive cost of Steel, Transportation, Loading, Unloading and all Taxes, etc., at the Godown point.
The rate shall be quoted in schedule – 1 (Format attached)
- 4) After submitting the applications by interested Companies, the APSHCL will examine the applications and documents furnished by the Companies and depute the Executive Engineers/Dy.Executive Engineers of the APSHCL to the plants of the Steel Companies to verify the availability of minimum production facilities, testing facilities etc.
- 5) Based on the inspection reports of officials of APSHCL, empanelment of the Companies will be made.
- 6) After empanelment of the Companies by the Head Office of APSHCL, the District units of APSHCL will invite sealed quotations from the empanelled Companies for their requirements of Steel from time to time and finalize the rates as per the due procedures for procurement of Steel.

- 7) As per the finalized rates, the District units of APSHCL will place purchase orders on the Companies giving quantity & destination wise details and other terms and conditions.
- 8) The Steel has to be supplied by the Company to the godown points of APSHCL as per the purchase orders including transportation, loading, unloading and stacking at the godown points.
- 9) The quantity of Steel supplied shall be confirmed to IS 1786 – 2008 standards of specifications with latest amendments if any.
- 10) The requirements as per IS 1786 – 2008 are as follows:

- 11) The Company shall manufacture Steel bars from out of MS Billets only.
- 12) The Company shall emboss Company Brand emblem on each bar.
- 13) The Company shall furnish the test certificates for every consignment.
- 14) The Steel shall be weighed at the nearest Weigh Bridge identified by the APSHCL staff. The weight recorded at Weigh Bridge is final for the purpose of payment.
- 15) Payment to the Steel supplied will be made by the District units of APSHCL after confirmation of the quality by sending samples of the Steel supplied to any one of the following laboratories.

- 16) The samples will be collected for every consignment/Purchase order. The APSHCL shall give (5) days advance notice in writing to the Steel Company to depute their representative for collection of samples jointly by affixing their signatures. In case the Steel Company fails to respond to depute their representative within 5 days, the sample will be collected by the APSHCL representative without waiting and the sample thus collected shall be deemed as jointly collected sample and the results of test so conducted on those samples shall hold good and final and the same shall be binding on both the parties.
- 17) No advance payment will be made to the Steel Companies under any circumstances.
